### SECTION 4: First aid measures

#### 4.1. Description of first aid measures

<b>General information</b>	Get medical attention immediately. Show this Safety Data Sheet to the medical personnel.
<b>Inhalation</b>	Remove affected person from source of contamination. Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. Maintain an open airway. Loosen tight clothing such as collar, tie or belt. When breathing is difficult, properly trained personnel may assist affected person by administering oxygen. Place unconscious person on their side in the recovery position and ensure breathing can take place.

### 5.1. Extinguishing media

### 5.3. Advice for firefighters

**Protective actions during firefighting** Avoid breathing fire gases or vapours. Evacuate area. Keep upwind to avoid inhalation of gases, vapours, fumes and smoke. Ventilate closed spaces before entering them. Cool containers exposed to heat with water spray and remove them from the fire area if it can be done without risk. No smoking, sparks, flames or other sources of ignition near spillage. Approach the spillage from upwind. Under normal conditions of handling and storage, spillages from aerosol containers are unlikely. If aerosol cans are ruptured, care should be taken due to the rapid escape of the pressurised contents and propellant. Small Spillages: Wipe up with an absorbent cloth and dispose of waste safely. Large Spillages: If the product is soluble in water, dilute the spillage with water and mop it up. Alternatively, or if it is not water-soluble, absorb the spillage with an inert, dry material and place it in a suitable waste disposal container. Flush contaminated area with plenty of water. ### 7.1. Precautions for safe handling

#### Usage precautions

<b>Appropriate engineering controls</b>	Provide adequate ventilation.
